

REGULATION #5600 - CHART OF DISCIPLINE - GRADES PREK – 6

In accordance with N.J.A.C. 18A:37-2a, students in grades kindergarten through 2 shall not receive an out-of-school suspension, except when the suspension is based on conduct that is of a violent or sexual nature that endangers others.
